Please read the following information on how your child can participate in the 2019 production of *The Nutcracker*.

Conditions of Participation:

- Your OCBT Performance Fee portion due per Academy level (as stated on your agreement) must be paid by December 1st—costumes are included.
- All Nutcracker Participants are responsible for 10 ADULT commitment service hours and 2 dozen concession items/bake goods.
- If unable to do personal hours or provide baked goods, ask about our commitment "buyout" option.
- Students will be required to perform in ALL shows unless prior arrangement has been made upon signing of this Participation Agreement.
- Attendance of regular classes are required.
- All rehearsals are mandatory no more than 2 absences will be allowed. Schedules are posted at the studio and communicated by email.
- Tech and Dress Rehearsals are MANDATORY or they may be dropped from the performance.
- No refunds will be given after castlist is posted.
